To write the history of a company as large as Gas Natural Fenosa is a challenge -an important one- because the writer has to find a style to recount a business evolution of more than 170 years through its most important events and milestones, its decisive moments and its more difficult times, all in an accurate and readable way.

Gas Natural Fenosa is an important company, one of the top ten companies in Spain today, as it was a hundred years ago. Gas Natural Fenosa's continuity is not only impressive, but also unique. The company is the result of the integration of several well-known companies; each one with its own personality and history but all contributing to the common heritage and taking roots in the various territories they have served. The company's great capacity for struggle and survival has been tempered over time by a high dosage of high-set dreams and determination as well as by its various confrontations with powerful multinational corporations from the 19th century on, and by continuous regulatory arguments both in the national and international sphere.

Since a company's age and status are always important in the energy sector, Gas Natural Fenosa has become a pioneer in introducing new technologies and new energy sources such as natural gas and nuclear energy in Spain. The company has always been forward-looking in its approaches to information technology systems and transparency as well as environmental and corporate social responsibility issues. It has a clear concern for its stakeholders and for any subtle indications coming from community.

Over the years, the corporation has been careful about keeping record of its history, the Historical Archives and Gas Museum being two clear examples. Strangely enough, however, the history of the company has never published until now. When the corporation turned 125 in 1968, Francisco Falgueras Roca, Manager of the company, began to gather information in order to prepare a book that would be entitled A Hundred Year-Old Industry . I was working for him at the time in the Corporate Strategic Department, and I received the assignment to write the last chapter of the book, which was supposed to talk about the future: the introduction of natural gas in Spain. The text was never actually published but has been consulted by many researchers over the years.

In 1993 the corporation turned 150, but Catalana de Gas and Gas Madrid had just recently merged and it was thought to be inappropriate to publish the corporation's history then, so it was substituted by the biography of José Roura y Estrada, the scientist who made the first laboratory experiments for gas-lit street lamps in Spain, in the cities of Barcelona and Madrid. The corporation turned 171 in 2014 and it is now that we can finally bring to light its History, that some will deem excessive and others will find incomplete, but which serves, in any case, as the first written evidence of the progression of a corporation established in 1843 as Sociedad Catalana para el Alumbrado por Gas, currently known as Gas Natural Fenosa.

I cannot deny my satisfaction and joy when Mr. Salvador Gabarró, Chairman of the Board of Directors, asked to me to write this book; after having devoted 47 years of my life to working in the company and having invested great efforts in the preservation and spreading of its history, documents, and images. I would like the to thank my beloved family: my wife, my children and grandchildren, for their endless support and their encouragement during the more difficult months of the research and writing of this book. This final work would not have been possible without them, without their interest and unfaltering support.



Devoted to the growth and stimulation of civil society, he currently serves as Chairman of Coordinadora Catalana de Fundaciones and Deputy Chairman of Fundació BCN Formació Professional. He is a Member of the Board of Trustees of Fundación del Real Monasterio de Santa Maria de Poblet and Fundación Bosch y Cardellach, and Member of the Board of Directors of Asociación del Museo de la Ciencia Técnica y de la Arqueología Industrial de Cataluña. He was founding member and first Chairman of the Institutional Board of ESADE Alumni, currently being its Honorary Chairman.

As a historian and communicator, he has published five books on the history of companies, entrepreneurs and institutions: Un científico catalán del siglo XIX: José Roura y Estrada (A nineteenth century Catalan scientist: José Roura y Estrada); La globalización en el siglo XIX: Málaga y el gas (Globalization in the nineteenth century: Malaga and gas) winner of the Ateneo de Sevilla 2001 History Award; Raíces de un futuro: Una historia de ESADE y de la Asociación de Antiguos Alumnos (Roots of a future: a History of ESADE and its Alumni Association); Mutua Universal: Los primeros cien años (Mutua Universal: the first century); and the biography of Pere Duran Farell. He has also collaborated in several collective books and presented over 100 lectures at various universities and business forums.

He spent his career as a Manager of Gas Natural Fenosa for 47 years, 30 of them as a member of the Management Committee, with responsibilities in the economic and financial, strategy, planning, systems and e-Business fields. Throughout these years he combined his professional activities with a thorough investigation of the company's history and a deep concern for the preservation of its historical heritage, thus creating the company's Historical Archives in 1987. He was appointed Member of the Board of Directors of Catalana de Gas y Electricidad from 1984 to 1989. He has also served as a Board Member of 31 companies. He ended his career as Chairman of Fundación Gas Natural Fenosa (2004-2013) promoting the Gas Museum in Sabadell, one of a kind in Spain.
